- Nursing Student Assistance Program**
Scholarship assistance to nursing students pursuing degrees and who are interested in practicing nursing in Oklahoma.
- Administration/Data Processing/Physician Placement**
Salary/benefits, operating expenses, travel, and placement services for physicians and communities through Oklahoma.
- Physician Assistant Scholarship Program**
Financial assistance to physician assistant students who in turn agree to fulfill their obligation in a rural community of 20,000 or less population.
